#### WAY OF FILLING IN MANAGING COMMITTEE

lf any vacancy occurs in the Managing Committee members/trustees on account of disgualification of a trustee or on account of vacancy due to death or resignation or if a trustee desires to be discharged or relieved from the trusteeship, then the continuing or surviving trustees shall appoint a new trustee in the vacancy caused by majority, from amongst the members. The person so appointed in the vacancy created shall work only for the remaining term of vacancy.

#### 8. GENERAL BODY

The General Body shall consist of all categories of members.

ii) The General Body shall normally meet once in a year or more often, if required.

The meeting of the General Body shall be presided over by the President or in his absence by the Secretary, and in absence of both by a member so elected from the Managing Committee, or in special circumstances a person from the General Body.

- Minimum 7 members will have to be present to frame a quorum at a meeting of the General Body.
- If at a duly convened meeting of the General Body, there be no V) quorum at the time announced for the meeting, the meeting shall be adjourned. The adjourned meeting shall be held after half an hour in which the members present shall form the quorum. However, the same agenda will be considered at the adjourned meeting.

All matters placed before the General Body for which no higher vi) majority is prescribed, shall be decided by simple majority or show of hands, or by ballot, if demanded by arty ten or more members present. In case of equality of votes, the President of the meeting shall have a casting vote.

The Secretary on the instructions of the Managing Committee and vii) in consultation with the President shall convene the meeting of the General Body with at least 15 days clear notice. The notice of the meeting shall contain a specific agenda to be discussed at the meeting. The said notice shall be sent under the Certificate of Posting or by any other method as per the choice of the President to all members.

#### 9. MANAGING COMMITTEE

The management and control of the Society shall be at present vested in a Managing Committee of 11 (Eleven) members. The number of Managing Committee shall be minimum 11 (Eleven) members and maximum 15.

The tenure of the Managing Committee shall be of 5 (five) years. All the Committee members are re-eligible for contesting the election, if required an independent Election Officer can be appointed 15 days before the election- to conduct the elections. The Managing committee shall consist of the following office bearers.

1) President 2) Vice-President 3) Secretary 4) Treasurer 5) Advisor

#### 10. MANAGING COMMITTEE:- (MEETING, NOTICE& QUORAM)

- The President shall preside at all the meetings of the Managing i) Committee. In his absence, the Secretary shall preside over the meeting, and in absence of both, the Managing Committee shall elect/ select one of its member to preside the meeting.
- Form a quorum at the meeting of the Managing Committee. If at a ii) duly convened meeting of the Managing Committee, there be no quorum at the time announced for the meeting, the meeting shall be adjourned. The adjourned meeting shall be held after half an hour for which the members present shall form the quorum. However, the- same agenda will be considered at the adjourned meeting.
- The Managing Committee shall meet once in every 4 (four) months iii) or more often as thought fit and proper.
- Notice of Managing Committee meeting shall, he sent 8 (Eight) iv) clear days in advance before the meeting by Ordinary Post or by any other method to be decided by the Managing Committee.








#### 15. EXTRA ORDINARY MEETING OF THE MANAGING COMMITTEE

Under special and/or extra ordinary Circumstances the President of the Society is entitled to call the Extra Ordinary Meeting to discuss and take decisions on policy matters pertaining to the Society. The notice for such meeting shall be signed by the President and Secretary, and shall be dispatched to all the Managing Committee members at least 24 hours before the meeting. The mode of sending the notice shall also be decided by the President. 7 members of the total number of members shall form the quorum. If quorum is not available within quarter of an hour at the time fixed the meeting shall stand adjourned by 3 days, and in such adjourned meeting the members present shall form the quorum. No other business than what is mentioned in the agenda shall be discussed in such meeting.

#### 16. CIRCULAR RESOLUTION

In urgent matters a circular resolution can be passed. The said resolution should bears signatures of elected President and Secretary and shall be circulated to the other Managing Committee members. If all the Managing Committee members sign on the circular resolution the contents of the same shall come into operation from the date of the resolution.





Such meeting shall be held within 30 days if the redustion by at least 7 members of the total number of members on roll provided that the request is made in writing to the President 'stating the business proposed to be discussed. The notice for this meeting should be 15 days in advance. No other business shall be discussed at the Requisition meeting other than the specific purpose for which the meeting is being called.

Decisions shall be taken by a simple majority of 7 votes. President shall have a casting vote in case of a tie. The quorum for the transaction of business shall be 7 members. In the event of quorum not being present within half an hour for the time set for the meeting, the meeting shall stand adjourned and re-assemble after half an hour. At such adjourned meeting, the rule of quorum shall not apply.

#### 18. VOTING RIGHTS

17.

Every member other than honorary member who is a member of the Society for three consecutive years will have the right for one vote to be exercised at the General Body meeting. All decisions will be arrived at in the General Body as well as Managing Committee meeting by a majority of 7 votes. In the event of a tie, the President shall have the power of deciding the issue by a casting vote.

### 19. FUNDS

The funds of the Society shall consist of subscriptions, and donations and such other funds received from whatever source, and the same shall be deposited in any Nationalized or Cooperative or Multi National Bank or Public Securities approved by the Managing Committee.

The income, money and properties of the Society, in whatsoever manner derived, shall be applied solely towards the maintenance, upkeep and improvement of the institution and properties of the Society and for acquisition of new ones, and for the promotion of all or any of the objectives specified above and no portion thereof 'Shall be paid or transferred directly or indirectly by way of profit to the members of the Society, PROVIDED and howsoever that nothing herein shall prevent in good faith remuneration to any member in return for any service rendered to the Society.

The Society may establish general, special or capital funds for Furtherance of the aims and objectives of the Society, and the money shall be deposited in Nationalized and/or Co-operative, Multi National banks or Public Securities.

## 20. ACCOUNTING YEAR

#### 23. CHANGE IN RULES AND REGULATIONS

Any change to be done in the Rules and Regulations will be done by calling special General Body meeting and 7/11<sup>th</sup> of the total number of members should be present for the said meeting and the said change should be accepted in the said meeting by majority. A copy of proposed change(s) in Rules and Regulations shall be sent along with Notice to the members well in advance.

#### 24. LIST OF MEMBERS

The list of persons who are members within the meaning of Section 15 of the Societies Registration Act, 1860, shall be maintained in the form of Schedule VI to the Societies Registration (Maharashtra) Rules, 1971, vide Rules 15 thereof.

#### 25. INDEMNITY

The office bearers and the members of the Society shall be indemnified in respect of acts done by them for the Society in good faith, and no office bearer or member of the Society shall be liable for such act done by any other office bearer, or member of the Society.

ii) No act or proceedings of the Society shall be deemed to be invalid by a reason merely of any vacancy in and/or defect or deficiency in the construction of Memorandum of Association of the Society/Rule and Regulations thereof as the case may be.

### 28. DISSOLUTION

If for any reasons it is decided to dissolve the Society, the provision of sec. 13 and 14 of the Societies Registration Act, 1860, shall be complied with.

In the event of dissolution the surplus assets/funds of the Society as would remain after discharging all liabilities shall be transferred to any other Public Charitable Institution/Society having similar objects, and also registered u/s 12A of Income Tax Act, 1961, and the same shall not under any circumstances be distributed among the members.
